Brief Outline of your career and achievements:

What was the most significant change within the profession during your involvement with ADOHTA?

Titles of Submissions/Activities:

- Submission to the Hon. Jack Snelling (SA Minister for Health) on the removal of the bar on independent practice for oral health practitioners in 2017.
- Submissions to other state and federal ministers/departments assisting in the transition to independent practice in the 2020 scope of practice standards.
- Strengthened relationships with stakeholders such as ADIA, DHAA, AHHA, Department of Health, and the PHAA.

Served on the board during and contributed to the extensive advocacy efforts resulting in the removal of the bar on independent practice for dental therapists, dental hygienists, and oral health therapists. Leticia also contributed to the advocacy efforts for oral health practitioners to obtain Medicare provider numbers.

Brief Outline of your career and achievements cont:

As ADOHTA National President, Leticia saw through the ongoing scope of practice and provider number advocacy, championing for the rights of oral health practitioners and their ability to provide quality care to patients. Perhaps most notably, Leticia played a pivotal role in facilitating the transition of ADOHTA from an incorporated association to a company limited by guarantee. She worked closely with external experts and maintained relationships with the closing state branches to ensure a seamless transition.

Leticia's commitment to ADOHTA continued even during the challenging year of 2020, when she worked tirelessly to help with submissions to ministers and health departments to advocate for the new scope of practice standards.
